

<u>Linda Joy Awards and Helen Hill Award - Application Guidelines</u>

The Atlantic Filmmakers Cooperative provides three awards to filmmakers annually at the Atlantic International Film Festival in September that supports the future projects of three Atlantic Canadian filmmakers (not restricted to Nova Scotia) through the Linda Joy Awards and the Helen Hill Award.

Award winners are determined through a peer-juried process. If you'd like to participate on a future AFCOOP peer jury please email Henry: henry@afcoop.ca

There is only one application intake per year on September 1st. Applications will be accepted online only up until 11:59pm AST.

The Linda Joy Award

- \$2,000 cash
- 2 x workshops of your choice
- Associate Membership
- Ability to be covered under AFCOOP's General Liability and Production insurance if required.
- In-kind camera package from AFCOOP
- \$5,000 in-kind lighting and grip package courtesy of Sunbelt Rentals Halifax*

*The Newfoundland Independent Filmmakers Co-operative (NIFCO) will provide \$3,000 in-kind gear if a filmmaker from Newfoundland receives the award.

*The New Brunswick Film Co-operative will provide \$3,000 in-kind gear for the Linda Joy Award, as well as cash top up from the Jane LeBlanc Legacy Fund if a filmmaker from New Brunswick receives the award.

*FilmPEI will provide \$5,000 in-kind gear for the Linda Joy Award if a filmmaker from Prince Edward Island receives the award.

The Linda Joy Post Award

• \$1,000 cash



\$2,000 (valued at regular rates) in-kind access to AFCOOP's Media Suite*

*NIFCO will provide \$3,000 in-kind for post-production for the Linda Joy Post Award if a filmmaker from Newfoundland receives the award.

*NB Film Co-op will provide \$2,000 in-kind for post-production for the Linda Joy Post Award if a filmmaker from New Brunswick receives the award.

*FilmPEI will provide \$2,000 in-kind for post-production for the Linda Joy Post Award if a filmmaker from Prince Edward Island receives the award.

ELIGIBILITY FOR THE LINDA JOY AWARDS

- Applicants must be residents of Atlantic Canada.
- Past recipients can apply again at least 12 months after receiving their past award as long as their past project is completed, and required reports and material have been received by AFCOOP.
- Requests for retroactive financing are ineligible.
- The project for which funding is applied must be targeted for completion for one-year after receiving the award.
- Those applying to the Linda Joy Post Award must restrict their project length to no longer than a 15 minute short film.
- The applicant must retain full creative control and ownership of the project throughout the production process.
- Students are ineligible

Helen Hill Award

The Helen Hill Animation Award is open to artists working in animation and experimental forms in Nova Scotia.

- \$1,000 cash
- \$2,000 in kind equipment and facility access from AFCOOP (valued at commercial rates)
- One full year of Editing and Producing memberships, (valued at \$1,070), from the Centre for Art Tapes (CFAT)



ELIGIBILITY FOR THE HELEN HILL AWARD

- Applicants must be residents of Atlantic Canada (note that sponsorship services are located in Halifax, NS)
- Past recipients can apply again at least 12 months after receiving their past award as long as their past project is completed, and required reports and material have been received by AFCOOP.
- Requests for retroactive financing are ineligible.
- The project for which funding is applied must be targeted for completion for one-year after receiving the award.
- There are no restrictions on project length.
- The applicant must retain full creative control and ownership of the project throughout the production process.
